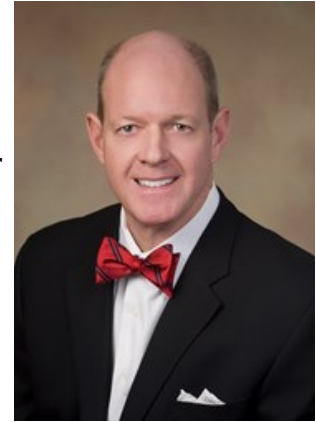
Tiffanie Clausewitz

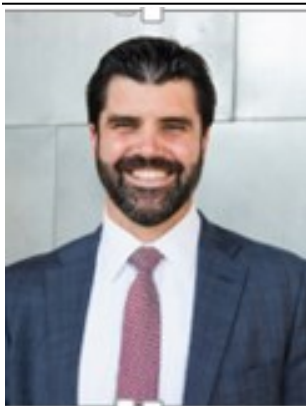
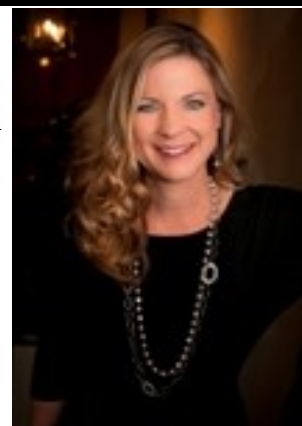
Robert Miller
