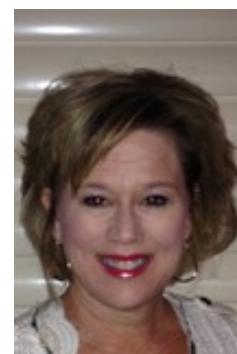


Jasmin Dean
